Notice of Race

1.0 Rules

- 1.1 The Regatta will be governed by the 'rules' as defined in "*The Racing Rules of Sailing*".
- 1.2 The Elliott 5.9 Class Rules apply to all boats racing in the Elliott 5.9 class.
- 1.3 The Yachting New Zealand Safety Regulations of Sailing Part 1 will apply to the Elliott 5.9 class.
- 1.4 The Yachting New Zealand Safety Regulations Part VI will apply to Sports Boat class.
- 1.5 The Yachting New Zealand Safety Regulations Part V, Category C will apply to Sports Trailer Boat class.
- 1.6 Appendix T will apply.
- 1.7 Each yacht shall be insured with valid third-party liability insurance with a minimum cover of \$2,000,000 per event. Evidence of insurance shall be provided by 1700 hrs on the day before the first race the yacht intends to compete in.

2.0 Eligibility and Entry

- 2.1 The regatta is open to all boats of Elliott 5.9 Class whose owners are full financial members of the Elliott 5.9 Class Association.
- 2.2 The regatta is also open to all Sports Boats that meet the definition under Yachting New Zealand Safety Regulations Part VI.
- 2.3 The regatta is also open to all Sports Trailer Boats that meet the definition under Yachting New Zealand Safety Regulations Part V.
- 2.3 The helmsperson must be a financial member of a member club of Yachting New Zealand.
- 2.4 For boats sailing in the Elliott 5.9 class the helmsperson must be a financial member of the Elliott 5.9 Class Association.
- 2.5 Advance Series entries will be accepted until the normal closing date of 1600 hrs. Thursday 12 August 2021, by completing the attached entry form, and mailing it to BBYC, P O Box 54 005, The Marina, Auckland 2144, or emailing to racingentry@bbyc.org.nz
- 2.6 Entry fee for the Elliott 5.9 Class is paid by the Elliott 5.9 Association for any boat with an existing entry to the Elliott 5.9 Traveller Series, Entry fee for the Sports Boat and Sports Trailer Boat class is \$50.00 to be paid with Entry Form.
- 2.6 Late entries may be accepted at the Race Committee's discretion.

5.0 Racing Area

The races will be held in the area bounded by Rangitoto Island, Browns Island and Bean Rock. With the aim to be racing in the vicinity of Motukorea Beacon.

6.0 Courses to be Sailed

6.1 The courses will be Windward/Leeward.

7.0 Scoring

7.1 The Low-Points scoring system of Appendix A will apply.

7.2 3 races will be required to be completed to constitute a series.

7.3 No score will be excluded until 5 races have been completed and a boat's worst score will be excluded when 5 races or greater have been completed.

9.0 Prizes

Prizes will be awarded at the Prizegiving at BBYC at the conclusion of racing on Sunday 15 August 2021.
